

Job overview

We are seeking a Consultant Orthodontist to join our team at Torbay and South Devon NHS Foundation Trust.

Main duties of the job

As a Consultant Orthodontist, you will be part of an established, multidisciplinary team, and you will be involved with the care of adult and child patients with severe and complex malocclusions. You will be expected to undertake the orthodontic care of patients requiring Orthognathic Surgery, Orthodontic/ Restorative treatment, dento- alveolar surgery, and complex Orthodontic treatment. Cases requiring multi-disciplinary care are seen with colleagues in the Maxillofacial & Restorative Dentistry specialties. You will be expected to provide advice for General Dental Practitioners, General Medical Practitioners, to be involved with local and regional professional networks, and participate in relevant local, regional and national audit and quality assurance processes. This will include the responsibility for and arrangement of communication and liaison with all other medical and service departments within the Trust as well as other Trusts.

You will provide high quality care, including clinical leadership and supervision of junior medical staff, ensuring the highest standards of clinical care are provided to all patients attending the hospital. You will be involved with recruitment, appointment and educational supervision of junior trainees, including educational contracts, regular appraisal, organisation of study leave, annual leave and rotas. You will need to be proactive in ensuring that all patients receive rapid assessment, treatment and clinical decision making, whilst ensuring our standards to deliver safe quality and performance are sustained.

You will be involved with teaching and training at undergraduate and postgraduate level and supervise and train the Specialist Registrars in Orthodontics, Oral Surgery and Maxillofacial Surgery, DCTs, specialty doctors, and staff within the department and the wider community. You will need to be proactive in the department's clinical governance agenda, take on leadership roles to support continuous learning and Clinical supervision and teaching, and have an active role in the junior doctor training programme. There is the opportunity to teach at the Peninsula Dental School in Plymouth/Exeter, and to get involved with the Regional SW Orthodontic Postgraduate Teaching programme.

This post offers the exciting opportunity of growing and developing your special interest, and building up a solid base of evidence and research in your field. The other Consultant Orthodontist in the department has an interest in Orthognathic Surgery, and you are encouraged to expand upon the base of care of patients with complex multidisciplinary problems.

About your new team and department

This is an opportunity to join the well-established, progressive department of Orthodontics at Torbay Hospital. The successful applicant(s) will join a highly motivated, dynamic team, responsible for the management and treatment of orthodontic patients with the emphasis on multidisciplinary care.
